# Mayor's Corner Happy New Year!

Ray Smith, Mayor

2019 was a year of significant growth for Coburg. Oregon state laws require cities to plan for growth. I learned many years ago that you cannot locally mandate a "no growth" policy. However, we do have control over how that growth occurs. That is what motivated me to join the Coburg Planning Commission over 30 years ago. I believe our planning and subsequent adoption of ordinances and codes have worked quite well in trying to maintain the desired small-town livability of Coburg.

# The City Council moves into 2020 with some big decisions ahead of us.

One of the first issues we will tackle is upgrading the condition of our streets. An astounding 80 percent approval of a local gas tax increase is a major step to-

wards financing about \$2.5 million of deferred repairs needed to bring our streets to an acceptable standard. The next step is to look at the possibility of charging a small monthly fee to residents and businesses. This was part of a recommendation presented to the council by a citizens committee. This committee was made up of residents and business representatives that spent about a year learning about our streets and what was needed to repair them. That recommendation brought two suggested revenues sources; the gas tax and a Transportation Utility Fee or TUF. The TUF will be the subject of public hearings and an opportunity for the public to give input on this potential revenue. The City Council and I want to hear from the residents. The city staff will be gathering and distributing information to our citizens and council. City Council will then receive and review input we

#### Meter Change out Project

New radio read meters will begin to be installed throughout the City in the months of January and February. The installation will not include new development which took place in the last 1.5 years, because they already have radio read meters currently. The new meters will cut down the reading time from two days to 45 minutes. It will allow operators to help customers look into water consumption issues such as leaks. We will be knocking on doors during the installation. The meter switch-out should only take a few minutes. If

the crew develops an issue, it could take a little longer.

Leaf pickup has begun. Crews are out picking up piles now. We ask if you have a pile of leaves to pick up that it is located where the crew get to it easily.

## **Public Partnerships and Mutual Aid Agreements**

In an emergency Americans reach out to their neighbors. Historically, it is when we are at our best. Neighbors helping neighbors can define how a community addresses an event, incident, or a challenge the community is facing, and directly influences the long-range recovery, health and resilience of the community.

Across America, local government is realizing the value of reaching out to neighboring communities to provide mutual support. This support comes in the form of mutual aid agreements, shared services, and intergovernmental agreements. They determine how partners will respond to a crisis, how they will share resources, and defines the financial and risk responsibilities of both partners. Often, FEMA reimbursements to communities require such agreements be in order and established protocols be followed.

On January 14, Coburg City
Council will consider a mutual
aid agreement between the
City and Coburg Fire District.
Although, historically both
agencies have worked well
together in emergencies such
as winter storms, defining the
specifics of the partnership
is critically important in
order for each partner to
have clear expectations
and responsibilities when

responding together to an incident.

Also in the works is a similar mutual aid agreement with the City of Harrisburg. Our partners to the north are our most natural neighbor in a major incident. Coburg is separated from the rest of the County by bridges, and the McKenzie and Willamette Rivers. During an incident such as a weather event, or natural disaster, response from the County could be limited to outlying communities. We should be prepared to shelter in place, and respond as a community. Harrisburg and Coburg do not have the physical barriers and are in the perfect position to provide response to one another. This could be shared resources such as equipment, or it could be the response of our police, fire or public works teams.

In the summer months the City of Harrisburg approached the City of Coburg asking if our Police Department might be able to provide some additional traffic support to their City. Their request was that we consider a short-term pilot program in which Coburg Police could provide 20-25 hours a month traffic control in their school zones, and other areas where speed is an issue. This is another opportunity for our communities to share in resources. The intergovernmental agreement, if approved, would establish how this project will work, how the City will be reimbursed, and what the expectations are of both

partners. This coverage would largely be covered by Coburg reserve officers. The City Council will consider the proposal for this pilot program at their January 14th City Council meeting. Another way that our City is working with partners is the formation of the CERT Team (Citizen Emergency Response Team). This is a team of volunteer citizens training together to respond to emergency in our community. Members of the Coburg team are training with other regional teams and represent both Coburg and Harrisburg with the volunteers that have stepped up to the call for response volunteers.

Coburg is small, but it is mighty in how the citizens, local government agencies, and emergency responders work together.

Working with our neighbors to the north only makes us stronger and encourages us to be ready to help one another by planning for response together.

As always, City Council is interested in public input on these matters and encourages public comment at City Council meetings. The next meeting will be held at 7:00 p.m. on January 14th at City Hall.

## **Coburg Area Emergency Readiness**

#### What is Shelter in Place?

"Shelter in place" is a method of protecting people from outdoor emergency incidents that might be a natural hazard, or a chemical spill, or a hostile person. Rather than trying to notify residents of a neighborhood and evacuating them to another location (a time-consuming task), it can make sense in fast moving situations to just have people sit tight and stay indoors until the danger is reduced or eliminated. Most buildings will provide some measure of protection from the danger, especially if the directions listed below are followed. Please keep this article is a safe place for reference if ever needed.

#### What Should You Do for Shelter in Place Instructions?

In most cases, this is what government authorities want you to do:

- Move people, pets and children indoors
- Move indoors and close your door (and lock it)
- Turn off your air conditioner and any appliance that pulls in outdoor air
- Close all windows, chimney dampers and vents
- Bring your cell phone, AM/FM radio and/or laptop with you inside the building

## **Public Notice - Coleman Street Funding**

As you may know the City of Coburg is undertaking several infrastructure projects at this time including the Water Master Plan improvement, and the repairs of the city streets in Coburg. City staff continuously attempt to combine projects in order to reduce costs to the taxpayers.

At this time, we are in the planning stages of work that needs to be completed on Coleman Street which addresses the need to replace mainline water pipe, as well as repair to the roadway. This work reflects planning for the "Collector" portion of the street between Mill and Dixon.

A collector street is a low-to-moderate-capacity road which serves to move traffic from local streets to arterial roads (in Coburg arterials are Pearl & Willamette which are both Lane County roads). These streets may look the same as a residential road, however, they are often wider and busier. When considering the planning for collector roads, public safety and traffic speed are of the utmost concern and focus.

City streets are categorized in

our adopted transportation plan as a local, collector or arterial. City development code addresses how roads will be developed and/or repaired according to categorization. The City of Coburg adopted the design standards for this code many times, but most recently in 2018.

#### Why is this important to you?

The current code requires that sidewalks be placed on collectors when they are reconstructed. This directly addresses the public safety issue. While the code does allow for other elements such as traffic calming round-abouts, islands, options for on-street parking, and width of the street, the sidewalk requirement offers less opportunity for design changes.

The Staff have requested the Council consider applying for grant funds in order to fund some of the required work on Coleman. This would be a regional grant that is funded by federal transportation dollars. This funding is reserved for projects such as collector streets that are improving the safety of citizens, and encouraging other modes of transportation such as biking, walking and transit. The recommended repairs needed on

Coleman involve both the water and street project. However, when the City agrees to receive these funds, we may be limiting our ability to change certain design standards. This is a difficult decision as federal transportation dollars are the only major funding opportunity for local streets in Coburg.

The staff and the City Council are very aware that this is an important issue to the community and therefore are inviting community input.

The Council will consider the request to apply for grant funding for this project at their meeting on January 14, 2020 at 7 p.m. The Public is invited to come to this meeting and provide comment on this matter.

Most of these projects are being financed by the user fees and systems development charges that we all pay when new homes and businesses are built and when we pay our monthly water bill. These projects have been planned for years and now that development has occurred, we must invest in upgrades and increase capacities.

City Council has directed staff to increase our communication with our citizens. We are committing more

resources to creating pamphlets, newsletters and other formats to inform all of our citizens about what we are doing and why it's being done.



I look forward to a prosperous year and I am committed to making Coburg city government approachable and deserving of our citizens trust.

- Move to the most inner part of the house/ building and stay there
- If instructed find duct tape or painter tape and seal any leaky windows/doors, Window/ wall-based vents or air conditioners should be covered with plastic wrap and tape, and even bathroom ceiling vent fans should get taped up
- If instructed go to an inner room and seal the door frame with tape
- Stay sheltered till given the all clear (usually hours are involved)
- Monitor your radio or cell phone for instructions and information
- DO NOT GO OUTSIDE unless an "ALL CLEAR" is given over cell phone or radio
