### **City Council Votes to Raise Sewer Fee**

The City Council mandates an annual financial review of our sewer operations in order to assure our operation costs and debt payments are appropriately covered by our revenue (sewer fees and taxes from the Urban Renewal District).

It is the priority of the City Council and staff to keep the rates as low as possible while being responsible to paying the debt and considering future operating costs.

This has been a very dynamic task considering the rapid growth of Coburg and many other less obvious factors that greatly affect the cost and revenue of the sewer system.

Every year, staff create a financial model with predictions of development growth, actual usage, maintenance and repairs, and revenues from monthly fees and property taxes collected from the Coburg Urban Renewal District. The costs of running the sewer department continue to rise as

the costs of materials and services have risen consistently at about 2% per year.

#### HISTORY OF RATES

**2014:** \$85.00 The initial monthly sewer rates were set.

**2016:** \$90.10 The financial model illustrated a need to adjust rates upward every year or the City would quickly exhaust available funds. The 2016 model also showed that operating costs were higher and there was a significant decrease in the Urban Renewal District tax revenue resulting from the reassessment of some industrial properties after the economic crisis.

**2017:** \$85.00 Reduced rates. A number of factors contributed to a much more positive outlook including increased values in the Urban Renewal District.

**2020:** \$86.70 The model predicts the need to slightly raise the sewer fees to cover operating costs that continue to rise. The raise in fees

will equal \$1.70 per equivalent dwelling unit beginning with the August, 2020 billing and due in September. With the current projections, the model shows the need to raise the sewer rate slightly each year in the amount equal to about \$1.75 through 2023 and then by 1% after that. However, annually this will be revisited as it is based upon projections and is subject to change as economic and development conditions change in the community.

The Council decision for this increase in fees took place on July 14th. Public comment was welcome at the meeting. In addition, each utility customer was sent a mini-newsletter regarding this in their June utility bill. The City also posted information on social media. ### Face Coverings Required Statewide Effective July 1st

Face coverings are required for indoor public spaces in every county effective July 1st. Children under 12 years of age, as well as people with a disability or a medical condition that prevent them from wearing a face covering, are not required to wear one.

Know the Facts:

#### Fact: We wear face coverings to help slow the spread of COVID-19.

Face coverings help us keep our respiratory droplets to ourselves, which means people who wear them prevent spreading the virus to others. (1) There are many types of face coverings, scarves, bandanas, and homemade coverings with loops that go over the ears.

#### Fact: Face coverings don't cause dangerous carbon dioxide to build up.

Face coverings don't cause enough carbon dioxide build-up to cause ill effects in otherwise healthy people. (2) In fact, masks have a tighter seal than face coverings, and farm workers, custodial staff, and hospital employees all wear them to stay safe in their workplaces.

Remember, though, that the following people should not wear face coverings:

- Children under age 2 years
- Anyone who has a medical condition that makes it hard to breathe when wearing a face covering.
- Anyone who has a disability that prevents the individual from wearing a face covering.

Fact: Cloth face coverings do not increase your risk of infection when used properly in public settings.

We wear cloth face coverings to help protect other people in case we have the virus but no, wearing a cloth face covering doesn't raise your risk of infection. (3) Be sure to wash your hands before and after touching your face covering and wash it daily.

Fact: Face coverings do not cause the virus to

#### "reactivate."

Once you have a viral infection, wearing a face covering does not make it worse or make it last longer. It does, however, help you keep from spreading or passing it on it to others. (4)




### **Build Out Scenario Project**

Ever wonder what future development in Coburg could look like? Curious what current zoning code and design standards would allow to be built? To provoke answers to these questions and illustrate potential scenarios for future development in the community, the City of Coburg is working in partnership with Lane Council of Governments (LCOG) and the Urban Collaborative, LLC, to analyze the build out potential of the area, including residential and commercial lots.

The build out scenario project aims to explore development scenarios as the population grows. These scenarios will help the community to envision different types and densities of growth to better understand how it wants to grow. The scenarios address the projected increase in population with existing buildable land, meeting additional housing demand and employment needs over time.

There will be exciting opportunities for residents to engage with the build out scenario project, so please stay tuned while we work out the details!

#### Applications for Rent Assistance for Lane County Renters Open July 15

Eligibility applications for rent assistance for Lane County renters opens on Wednesday, July 15, at 9 a.m. and will close at 11:59 p.m. on Wednesday, July 22.

A total of \$5.1 million is available. The funding was provided by the federal COVID-19 CARES Act.

Eligible households that complete an application will be selected for funding via a lottery for expenses acquired beginning on March 1, 2020.

The results of the 2020 Census will help determine how hundreds of billions of dollars in federal funding flow into communities every year for the next decade. That funding shapes many different aspects of every community, no matter the size, no matter the location.

Or think of your local schools: Census results help determine how money is allocated for the Head Start program and for grants that support teachers and special education.
