

Mayor's Corner Planning In Our Town

On August 20, 2020, the Coburg City Council held a public meeting to hear an appeal to the Planning Commission's approval (with conditions) of a proposed development on the North End of Coburg. After presentations from all parties and much discussion by City Councilors, the applicant chose to withdraw the application for the subdivision.

Most (nearly all) of the discussion was regarding transportation.

Many options were presented and discussed. Even the Appellants stated they were not opposed to the development in general, just the traffic created by the development. Street access to the proposed development was the key issue. All traffic to and from the 46-home subdivision would be on two streets. One proposal would have only one street bear all the traffic. Here is the tricky part: present national standards allow

our engineer and fire district to deem this acceptable. The Coburg Comprehensive Plan states the city needs to be cognizant of the effects on existing neighborhoods.

Needless to say, this would have a profound effect on the city park area as well as the residents living on this street.

This was the friction in the decision the Councilors needed to consider when arriving at their decision.

We should all be proud of how our City Councilors listened, and represented the concerns of all citizens in the recent appeal hearing. My thanks to the City Councilors, and staff for their dedication.





Build Out Scenarios Project Update & LIVE SURVEY



In light of population projections that show growth will happen in Coburg, the City of Coburg is exploring some very different development scenarios.

These are hypothetical and are only intended to show what could happen on several open parcels of land around Coburg if developers just followed the current code requirements. These scenarios, for better or worse, help the city envision different development types and development densities. The scenarios address the projected increase in population with existing buildable land in order to meet additional housing demand and employment needs over time. While you may like or dislike some of the scenarios, they all could be built today following the current code. In the survey noted here, we ask what you like and dislike so that, in the future, we may be able to modify our code to ensure what

modify our code to ensure what gets built is closer to what the community envisions for Coburg consistent with applicable laws and regulations.

New Lamppost Banners

Coburg's lampposts are getting a makeover! The 24 new banners, purchased by the Coburg Car Classic in partnership with the City of Coburg, will line Willamette Street through the downtown corridor and feature a Penny-farthing bicycle.



Inspired by former Mayor Jim Broughton (pictured below), the Penny-farthing bicycle has become an iconic Coburg symbol and is also featured on the Loop Path signage.

The Public Works Department is working hard to have the banners installed before Labor Day.

What Is a Penny-Farthing?

The penny-farthing, also known as a high wheel, high wheeler or ordinary, was the first machine to be called a "bicycle." It was popular in the 1870s and 1880s, with its large front wheel providing high speeds (owing to it travelling a large distance for every rotation of the legs) and comfort (the large wheel provides greater shock absorption). The name came from the British penny and farthing coins, the former being much larger than the latter, so that the side view resembles a larger penny leading a smaller farthing.


Parks Update

Police Update

The Coburg Police Department has had several officers recently attain certifications that reflect commitment to public service and have received distinctions that reflect positively upon the Coburg Police Department and the City of Coburg.



Four officers recently graduated Reserve Officer Basic Mandate Training. The Reserve Officer Basic Mandate Academy began in September of 2019 and culminated on July 11,

2020 with their graduation ceremony.

The Reserve Basic Mandate Academy was hosted and facilitated by the Lane County Sheriff's Office with officers in attendance from many agencies. Those officers who graduated include: Ofc. Levi Gray, Ofc. Daniel Mattingly, Ofc. Jeremiah Rupe and Ofc. Jason Smith.

Special awards were received by the following officers from academy staff: Ofc. Daniel Mattingly received both the High Academic Award and the Overall Physical Fitness Award (he broke many academy fitness records), Ofc. Jeremiah Rupe received the Most Improved Physical Fitness Award (for having set, met and exceeded his fitness goals), and Ofc. Levi Gray received the High Firearms

Award. All of these officers are now in their Field Training and Evaluation phase.

Additionally, we had Sergeant David Gregory attend and graduate the Oregon Department of Public Safety Standards & Training (DPSST) Police Career Officer Development Course (PCOD). In part, the PCOD

Course is designed to grant Oregon licensure to out of state law enforcement transfer applicants that hold law enforcement certifications in other states, meet certain licensure requirements for Oregon, and attend and successfully pass

the Oregon DPSST PCOD Course. Sgt. Gregory met or exceeded all licensure requirements, and attained 100% on most all of his tests and exams associated with the PCOD Course.

in the meeting, I thought of the long process and the financial impact involved in keeping plans updated as required by the state.

In 2000, work began on updating the UGB (urban growth boundary), as well as The TSP (transportation system plan). The state requires cities to undertake this process.

The frustration with the UGB stems from the fact that public input was given through the required public hearing process.

The City worked with The Planning Commission, Coburg City Council, Lane County Board of Commissioners and the Department of Land Conservation and Development. All of these agencies must formally accept the plan through multiple public hearings.

After much time, effort, money, and collaboration with DLCD, a citizen who does not live in our city, along with Lane County Land Watch filed an appeal. LUBA (Land Use Board of Appeals) remanded it back to the City, we appealed the decision to the Court of Appeals. The Court essentially upheld the LUBA remand which invalidates the adoption of the plan.

Space prohibits me from going into the details of the LUBA remand, but essentially the state goals and desires overrode our local desires and goals.

This meant we were back to ground zero, time and money was lost, and we would have to begin the process again.

Nearly \$50,000 was spent from 2013-2017. This does not take into account planning costs in years prior to 2013. The costs for updating data and reports needed for the work to be done usually starts at about \$25,000, and escalates rapidly.

Even if the City Council took the shortest route and

updated the plans to address just the concern in the appeal, it would cost tens of thousands of dollars.



The City Council chose to wait

for the official population estimates to be released in 2021 before taking any further action. The population figures have a profound effect on how the City moves forward.

I am not making excuses but want citizens to understand how difficult and exhausting this process is.

Hopefully, you can understand the frustration we feel when we speak with our elected representatives and they acknowledge work needs to be done to fix the process, but year after year little to nothing changes.

I share this info with you because I believe it is important for our citizens to understand that our appointed and elected officials, and the City Of Coburg staff have worked diligently for many years to protect our citizen's wants and needs with thoughtful plans supported by codes and ordinances that provide protection of the safety and livability of our city.

I want to assure you we will all continue to work with Lane County and State Agencies to try and remedy the issues we face as a city, and avoid the issues we are currently dealing with in the future.
