Welcome 2022!

Happy New Year! We have slogged through another year of the COVID pandemic. As we start the third year of this cursed pandemic, I hold hope that we can begin to see some normality return to our lives. I still feel very fortunate to live in our wonderful little town. We closed out the year with a successful Christmas in Coburg weekend. Although the parade was a bit soggy, it was still well attended. It was good to see people gathering again.

In spite of the pandemic, Coburg has maintained its services and our businesses have remained open. Staffing for the restaurants has been an issue, but the customers have been patient and keep coming in. A new, smaller residential development has started construction on the north edge of town.

The city signed a lease with the

International Order of Odd Fellows (IOOF) for the use of the first floor and parking lot of the IOOF hall. This space is now available for community use and is being used to serve the Senior Meals every Wednesday. Soon after signing the lease, the City secured a grant for about \$7,000 to upgrade the IOOF kitchen. At the time of this writing, we have purchased a commercial refrigerator, a commercial dishwasher/sanitizer and a commercial sink unit. We have also updated to safer more functional and decorative lighting.

Coburg has a lot going on in 2022. We should start seeing some street improvement projects coming this summer. These will be funded by our recently implemented Transportation Utility Fee (TUF) and the increased gas tax revenues. We also hope to begin work on a new well and elevated water storage tank this year.



Coburg Heritage Committee

Coburg Main Street

The City's Economic Development Committee transitioned into Main Street last year, becoming part of a nation-wide Main Street program. Main Street America is a four-tier program that focuses on economic vitality, organization, design, and promotion.

Tracey Pugh was hired last August as the Main Street Coordinator, and is working to create a nonprofit 501 (C) 3 organization and Board of Directors that will work to inspire partnerships and community engagement bringing art, events, downtown beautification, promotion of businesses, and community vitality to Coburg.

The Coburg Main Street Mural Committee created the snowmen at the north and south ends of town and are working with the Grange and Charter School to put up artwork on the west side of the Grange.

Proposed projects for 2022 include: additional artwork and/or murals in downtown, business map and directory, wayfinding signage, central website for businesses and events, and hanging flower baskets in downtown.

Transportation Utility Fee - What Happens Next?

You have probably noticed the Transportation Utility Fee (TUF) on your monthly utility bill. This fee is a result of Ordinance A-252 which implemented a fee on utility bills in order to create a revenue stream for addressing the road conditions in Coburg.

Residents and business owners may be asking what is next? Here are a few facts you should know regarding this fee.

- 1. Funds raised through the TUF may only be spent on the roads as established in Ordinance A-252.
- 2. Local streets can't all be fixed at one time. City staff and engineers must be thoughtful in planning how repairs and treatments will take place. Fixing only the worst roads first is not the best action. It is equally important to treat the roads in good condition in order to maintain good condition. A balance of repairs and proactive treatments is the best plan moving forward.
- 3. Road construction, repairs and treatments must happen in the dryer months. This limits construction and maintenance to 4-5 months per year.
- 4. The City has obtained funding for some of the roads in Coburg which are time sensitive. For example, regional funding will help with the repairs needed on our collector streets such as stretches of Coleman, Mill and Skinner. However, those repairs will need to wait until 2023 when the funding is allocated. McKenzie Street rebuild in the Central Business District (Harrison to Willamette) is partially funded through Small Cities Allotment Grant, this project must take place in the summer of 2022. In addition, the City is in the process of applying for transportation loans and grants which will fund future projects.

When can I expect my road to be improved?

City staff have designed a transportation project list that will schedule all road construction and treatment over a five-year period. Obviously, we want to get to the worst roads as soon as possible. However, we must be thoughtful about the timing of when roads are torn up, and consider detours, and business, commuter and truck traffic. Our goal is to make disruption as painless as possible for our residents and local business. In addition, the City has water projects planned on some roads that are scheduled to have

repairs. Our hope is to align these projects as closely as possible in order to minimize the interruption to the community.

What should I expect when road construction is happening in my neighborhood?

Road construction in your neighborhood can be an inconvenience. Contractors do their best to consider the residents in the timing of their work. However, building roads to standards has requirements that can feel disruptive to the nearby residents. Therefore, there are rules about when roadwork can take place such as avoiding nights and weekends unless it is absolutely necessary.

Can I share my concerns regarding the street in front of my house?

Yes, the City has a Citizen Inquiry form that can be filled out and turned in. City staff will address your concerns in a timely manner. While we might not be able to address your concern immediately, we can let you know when to expect your concerns will be addressed.

Will the Transportation Utility Fee Sunset?

The TUF will be analyzed each year based upon the cost of the work that needs to be done, the amount of revenue the City is receiving, and the amount of debt that the City has had to take on to get the road work done. This helps the City Council with an informed decision about the length that a TUF will be charged, or if it can be reduced. With the volatility of construction costs at this time, it is very hard for the City to know what costs will be a few years from now. Our hope is that they will stabilize.

Can I apply for a reduction in TUF Costs?

Yes, residents who qualify for low-income assistance may apply for a TUF reduction. If you have already been approved for utility assistance, then it is likely that this reduction has already been applied to your bill.

What if I feel that my business TUF is improperly calculated?

Ordinance A-252 allows for an appeal of the TUF fee for businesses. Businesses must provide a reason why they feel that the associated trips to their business has been miscalculated. Appeal forms are available on the City website and at City Hall.

Coburg Community Grange

The Coburg Community Grange spent the month of November honoring our local Veterans and putting up banners for 15 of them.

We were very happy to team up with the City of Coburg to get these banners up. We plan to add 12 more banners next year, so if you know a Veteran who lives in the Coburg Fire District and served prior to 1975, please get a picture of them and send it to the Grange with a copy of their DD214, and their branch of service. At this time, we are honoring our living Veterans.

Thank you to Brian Harmon and the Public Works crew for all their help getting this project done.

The Grange also worked with Coburg Main Street to promote and produce this year's "Christmas in Coburg" event. Although it was a great success, we did have a few growing pains, but the committee learned a lot to incorporate for next year. Thank you to Tracey Pugh for putting together a fantastic event. Also a special Thank You to both John & Alice Brooks for helping with Snacks with Santa at the Grange, and for leading the parade and then greeting all the kids at Pavilion Park. We also hosted the annual Chili Feed in conjunction with the Block Party.

The Grange was also very happy to help support the annual Christmas light display that was set up in Pavilion Park. Please, if you see any of our Coburg Public Works crew, take the time to say thank you for the AWESOME job they did setting up this display. (If you happen to see our huge blow up Santa, that someone decided to borrow, ask them to please return it so the entire town can enjoy it.)

The Grange has also invested a few dollars into our building. Porch rails on the front and back of the Grange, new rails on the ADA ramp with new floor and sand paint to help the slipping on the porch, and we also added a new hood over the kitchen stove.

Keep your eyes open and focused on the west wall of the Grange building. We have partnered with the Main Street Art Committee and Coburg Community Charter School to display art work produced by students in K-8. Thank you Teri Kohley for taking the lead and moving this project forward. This is just the start of this ongoing project.


